

### e-ROC and e-REGO AUCTION CODE

This Auction Code sets out the rights and obligations of Participants in relation to the conduct of the Auction and the use of the Auction Site.

The Auction has been established by NFPAS acting as agent for various principals wishing to auction Renewables Obligation Certificates and/or Renewable Energy Guarantees of Origin Certificates in accordance with the e-ROC and e-REGO Conditions of Sale.

# 1. Definitions and Interpretation

In this Auction Code, the following words and expressions shall bear the following meanings unless the context requires otherwise:

"Auction" means the electronic auction conducted by NFPAS, commencing on the date specified by NFPAS on the Auction Site from time to time, in accordance with this Auction Code to determine the Participant who will

purchase each Lot on the e-ROC and e-REGO Conditions of Sale and the price such Participant shall pay for each Lot;

"Auction Period" means the time periods within which bids may be

submitted in respect of any Lot as specified by NFPAS

on the Auction Site from time to time;

"Auction Site" means the electronic site accessible by the Participants on

which the Auction will be conducted;

"Authority" means the Gas and Electricity Markets Authority

established under Section 1 of the Utilities Act 2000 or the Northern Ireland Authority for Energy Regulation created under Article 3 of the Energy (Northern Ireland) Order 2003, as applicable, or any successor from time to

time;

"Banking Days" means any day other than (a) Saturday or Sunday; (b)

Christmas Day or Good Friday; or (c) a day which is a bank holiday under the Banking and Financial Dealing

Act 1971 in any part of the United Kingdom;

"Bidding Hours" means the period from 10.00 am to 5.00 pm Monday to

Friday on each Banking Day of the Auction Period but shall not include any scheduled or unscheduled system downtime when the Auction Site or NFPAS is unable to

receive and/or process bids;

"e-ROC and e-REGO

Conditions of Sale" means the terms and conditions for the sale of

Renewables Obligation Certificates issued under the RO Order, the ROS Order or the RO(NI) Order and/or Renewable Energy Guarantees of Origin Certificates under the Electricity Regulations 2003, Electricity

Regulations (Northern Ireland) 2003

"Final Bid Price" means the final bid price of the Successful Bidder which

is accepted by NFPAS;

"Lot" means one or more Renewables Obligation Certificates

and/or Renewable Energy Guarantees of Origin Certificates which are identified by their certificate numbers and which are either identified as issued under the RO Order, the ROS Order ,the RO(NI) Order or the Electricity Regulations 2003, Electricity Regulations

(Northern Ireland) 2003

and made available for sale by NFPAS on behalf of the specified principal under the e-ROC and e-REGO Conditions of Sale that are available to be auctioned;

"NFPAS" means NFPAS Limited whose registered office is at

"Participant" means the party named as the Participant in the

Registration Form and "Participants" means all parties

participating in the Auction;

"Registration Form" means the "Registration Form for Participation in the

NFPAS e-ROC or e-REGO Auction" which is completed

in full and submitted by the Participant;

"Renewables Obligation means a ROC as defined in the RO Order, an SROC

**Certificate" or "ROC"** as defined in the ROS Order or a NIROC as defined in

the RO(NI) Order;

"Renewable Energy Guarantee

Of Origin Certificate" or "REGO" means a guarantee of origin as defined in the

Electricity (Guarantees of Electricity Produced from Renewable Energy Sources) Regulations 2003 and the Electricity (Guarantees of Electricity produced from renewable energy sources) Regulations (Northern

Ireland) 2003;

"Reserve Price" means, where applicable, the price notified by NFPAS on

the Auction Site as the minimum at which a Lot will be

sold at an Auction;

"RO Order" means the Renewables Obligation Order 2009;

"RO(NI) Order" means the Renewables Obligation Order (Northern

Ireland) 2009;

"ROS Order" means the Renewables Obligation (Scotland) Order

### "Successful Bidder"

is defined in Clause 5.1.

In this Auction Code, unless the context requires otherwise:

- references to singular shall include references in the plural and vice versa and words denoting natural persons shall include corporations and any other legal entity and vice versa;
- b) references to the word "including" are to be construed without limitation;
- c) references to any statute or statutory instrument or any section of a statute or statutory instrument shall be construed, at any particular time, as a reference to any modification, extension or re-enactment thereof then in force and to all instruments, orders or regulations then in force and made under or deriving validity from such statue or provision (as the same may have been modified, extended or re-enacted from time to time);
- except to the extent that the context requires otherwise references to a particular Clause, shall be references to that clause in this Auction Code;
- e) except to the extent that the context requires otherwise, any reference to "this Auction Code" is a reference to it as amended, supplemented or novated from time to time and includes a reference to any document which amends, is supplemental to, novates, or is entered into, made or given pursuant to or in accordance with any terms of it;
- f) where the Participant is a partnership or a firm, this Auction Code shall be binding upon each of the partners thereof from time to time as partners and individuals and their respective successors as partners and individuals and the executors and personal representatives of any such persons;
- g) where the Participant comprises two or more persons, any obligation of the Participant in, under or arising from this Auction Code is undertaken by or binding upon such two or more persons jointly and severally; and
- h) headings are inserted for convenience only and are to be ignored for the purposes of construction.

### 1. Registration

- 2.1 In order to participate in the Auction, the Participant shall submit to NFPAS (or its nominated representative) a completed and signed Registration Form.
- 2.2 By submitting the Registration Form, the Participant:
  - a) acknowledges that the information that is provided in the Registration Form may be used by NFPAS for the effective administration of the Auction and to communicate with the Participant;
  - b) warrants that the information is true, accurate and complete:
  - c) accepts the terms and conditions of this Auction Code; and
  - d) agrees to be bound by the e-ROC and e-REGO Conditions of Sale in respect of any Lot consisting of Renewables Obligation Certificates and REGOs issued under the RO Order, ROS Order ,RO(NI) Order and/or the Electricity Regulations 2003, Electricity Regulations (Northern Ireland) 2003 for which it is the Successful Bidder.
- 2.3 On receipt of the Registration Form signed in accordance with Clause 1, NFPAS shall issue the Participant with a unique username for use in all future Auctions together with a confidential security password to access the Auction Site and participate in the Auction. NFPAS shall issue



the Participant with a new confidential security password for each subsequent Auction. NFPAS agrees not to disclose the Participant's user name and security password to any other party.

- 2.4 The Participant shall at all times maintain the confidentiality of its user name and password. The Participant is responsible for all acts in relation to the Auction (including the submission of bids) referable to its user name and password, regardless of whether such acts are actually or expressly authorised by the Participant, unless such acts result directly from a breach of NFPAS's obligations of non-disclosure in Clause 2.3.
- 2.5 The Participant shall notify NFPAS immediately if it believes that its user name and password have been misused or compromised in any manner.

### 3 Operation of Auction

- 3.1 The Auction for each Lot shall be conducted on the Auction Site during the relevant Auction Period.
- 3.2 NFPAS shall ensure that the information set out in Schedule 1 of the Auction Code for each Lot is made available to the Participants via the Auction Site at least 2 Banking Days before the commencement of each Auction Period.

#### 4 Submission of Bids

- 4.1 During the Auction Period, the Participant may submit bids electronically through the Auction Site in respect of any Lot, provided that all bids submitted shall be:
  - a) positive and in the range of £1 to £200 per Renewables Obligation Certificate; or positive and in the range of 5p to £99.99 per REGO
  - b) in increments of not less than £0.10 per Renewables Obligation Certificate; or in increments of not less than 5p per REGO; and
  - c) in relation to any Lot in respect of which a Reserve Price has been specified, equal to or greater than the Reserve Price.

### 4.2 By submitting a bid, the Participant:

- a) acknowledges that it has examined all information made available by NFPAS through the Auction Site regarding the Lot (including the identity of the principal);
- b) irrevocably offers to pay the bid submitted as the price to be paid in respect of Renewables Obligation Certificates or REGOs included in such Lot in accordance with the e-ROC or e-REGO Conditions of Sale if it is the Successful Bidder; and
- c) warrants that neither its bid nor its participation in the Auction violates any laws nor breaches the terms of this Auction Code.
- 4.3 The Participant acknowledges that a bid is deemed to have been submitted only when a bid that is in conformity with the terms of the Auction Code has been received and processed by NFPAS.
- 4.4 NFPAS shall use all reasonable endeavours to process and post the highest bid received for each Lot at any point in time during the Auction Period at the Auction Site within 3 minutes of receipt. In the case of equal bids, the earliest bid received and processed by NFPAS will be deemed the higher bid.
- 4.5 During the Auction Period, NFPAS shall send as soon as reasonably practicable a notification to the Participant whose processed bid is the current highest bid and shall use all reasonable endeavours to do so within 5 minutes of posting that bid on the Auction Site. Such notification shall also be sent by e-mail as soon as reasonably practicable, to the e-mail address specified by



- the Participant in the Registration Form. The failure of the Participant to receive such notification shall not release the Participant from any obligations set out in this Auction Code.
- 4.6 Notwithstanding Clause b), NFPAS may in its sole and absolute discretion consent to a request from a Participant for withdrawal of a bid on the grounds that the bid contained an obvious typographical error. NFPAS is not obliged in any circumstances to consent to the withdrawal of any bid submitted.
- 4.7 In the event that a posted bid is subsequently withdrawn or removed pursuant to Clauses 4.6 or 9.3, NFPAS will have the right (in its absolute discretion) to cancel all bids submitted and restart the auction process and the Auction Period in respect of such Lot.

#### 5 Successful Bidder

- 5.1 NFPAS shall accept the bid of the "Successful Bidder" which shall in respect of any Lot be the Participant who has a) met and/or exceeded the Reserve Price of the Auction; and b) has the highest bid for the Lot (determined in accordance with Clause 4.4 in the case of equal bids):
  - a) for a continuous period of 30 minutes during the Bidding Hours; or
  - b) at the end of the Auction Period.
- 5.2 The Successful Bidder in respect of each of the Lots shall be absolutely and finally determined by NFPAS in accordance with the criteria set out in Clause 5.1 and by relying on the computer hardware, software and systems used by it to regulate the Auction.
- 5.3 NFPAS shall post the Final Bid Price in respect of each Lot at the Auction Site as soon as reasonably practicable and in any event within one Banking Day of the end of the Auction Period.
- 5.4 NFPAS shall send to the Successful Bidder an e-mail notification that it is the Successful Bidder (by e-mail to the address specified in the Registration Form) within one Banking Day of NFPAS's determination of that fact under Clause 5.2.
- 5.5 The Participant hereby authorises and directs NFPAS to submit an invoice to the address shown on the Registration Form giving details of the Lot(s) and Final Bid Price(s) and the total amount due for payment. The invoice value for each Lot shall be calculated by multiplying the Final Bid Price by the number of ROCs or REGOs in each Lot together with any Value Added Tax or any other tax that may apply.
- 5.6 The Participant acknowledges that if payment is not made within 7 days of the date of the Auction, NFPAS has the right to rescind the sale and may offer the Renewables Obligation Certificates or REGOs to an unsuccessful bidder (commencing with the next highest bidder and ending with the least highest bidder) or re-auction the Lot or exercise such other rights as it may have pursuant to the e-ROC and e-REGO Conditions of Sale.
- 5.7 Ownership of and title to the Lot purchased by the Successful Bidder shall not pass to the Successful Bidder until the Successful Bidder has made payment in full to NFPAS of the total amount due under the e-ROC and e-REGO Conditions of Sale.

### **6** Warranties by Participant

6.1 The Participant warrants and represents that it has the power to enter into, perform and comply with all its obligations under this Auction Code and any e-ROC and e-REGO Conditions of Sale which it is bound by as a result of the Auction and that its entry into, performance of or compliance with its obligations under this Auction Code and any applicable e-ROC and e-REGO



Conditions of Sale does not and will not violate any law to which it is subject or its constitutional or enabling documents.

- 6.2 The Participant warrants and represents that it has been granted and there subsists in respect of it a licence to supply electricity pursuant to Section 6 of the Electricity Act 1989 or Article 10 of the Electricity (Northern Ireland) Order 1992.
- 6.3 The Participant warrants and covenants that it shall comply with all applicable laws, statutes, statutory instruments, ordinances and regulations regarding its participation in the Auction.
- 6.4 The Participant warrants and covenants that it will:
  - a) not bid in a way that is manipulative of the Auction or conspire with other Participants to manipulate the Auction or any bidding;
  - b) not communicate in any manner with any other Participants in relation to the Auction;
  - c) not use any mechanism, device, software, script or computer programming routine (including any virus, worm, time bomb, cancelbot or trojan horse) that may damage, interfere with, delay, intercept, expropriate or otherwise affect the proper functioning of the Auction Site or any system, data or personal information related to the Auction Site;
  - d)not take any action that places an unreasonable burden or excessive load on the computer systems supporting the Auction Site; and
  - e) act in good faith in the participation in the Auction.

#### 7 Indemnity

The Participant agrees to indemnify and keep indemnified NFPAS, its officers, employees, agents and sub-contractors against all liabilities, claims and expenses (including reasonable legal fees) that may arise from any breach of the terms of this Auction Code by the Participant or any act referable to the Participant's user name and/or password (unless directly caused by a disclosure of the Participant's user name and security password by NFPAS in breach of Clause 2.3) or the violation by the Participant of any law or rights of NFPAS or any third party.

### 8 Suspension, Cancellation and Termination

The Participant acknowledges that NFPAS has the right to:

- a) refuse or remove any bids;
- b) shorten or extend any Auction Period;
- c) postpone, cancel or withdraw any Lot from the Auction;
- d) temporarily suspend or permanently terminate the Auction at any time; or
- e) refuse, temporarily suspend or permanently terminate the Participant's participation in the Auction,

where NFPAS has, in its opinion, reasonable grounds (including technical grounds) for so doing. Where practicable, NFPAS will provide reasonable advance notice (in the form of postings at the Auction Site) of any such steps that NFPAS intends to take.

#### 9 Disclaimer

9.1 The Auction Site is provided on an "as is", "as available" basis and NFPAS makes no representation and excludes any warranty, express or implied as to the availability, quality,

accuracy, timeliness, completeness, non-infringement, performance or fitness for a particular purpose of the Auction Site. In particular, NFPAS makes no representation or warranty that:

- a) access to the Auction Site will be free from infection by viruses or anything else that has contaminating or destructive properties; and
- b) access to the Auction Site and participation in the Auction (including the submission of bids) will be secure, uninterrupted and free of errors or free of downtime, outages or technical problems that may hinder the efficacy of a bid or the Auction (including transmission times or delays).

All such terms which would otherwise be implied into this Auction Code are hereby excluded to the fullest extent permitted by law. The Participant warrants that it has not relied on any representations made by NFPAS which have not been expressly stated in this Auction Code.

- 9.2 The information provided for each Lot at the Auction Site is information which has been provided to NFPAS in respect of that Lot, and has not been verified by NFPAS and NFPAS gives no warranties and makes no representations in respect of the status, value or authenticity of any Renewables Obligation Certificate or REGOs.
- 9.3 NFPAS will use reasonable efforts to correct errors or omissions in the information provided for each Lot at the Auction Site as quickly as practicable after being notified of them and shall notify the Participant of any corrections made by posting a notice on the Auction Site. In the event of any corrections being made to the information which, in NFPAS's opinion, materially affects the Participant's bid, the Participant may withdraw a bid placed in that Auction provided such bid was placed before the correction is made, and provided that the Participant has not become the Successful Bidder pursuant to Clause 5.

### 10 Liability

- 10.1 NFPAS, its officers, employees, agents and sub-contractors will not be liable to the Participant or any third party for:
  - a) any losses or claims (whether in contract, tort, negligence or otherwise) arising from any inability to access the Auction Site, any interruption in the conduct of the Auction, any postponement, cancellation or withdrawal of any Lot from the Auction in accordance with Clause 8 above, any refusal, suspension or termination of the Participant's participation in the Auction, any losses or claims arising from Lots offered on the Auction Site;
  - b) any exemplary, incidental, special, indirect or consequential loss or damage, or for any loss of data, sales, profit, revenue, opportunity, information, business or anticipated savings, or loss or wasted time, howsoever caused (whether arising out of any tort, negligence or breach of this Auction Code or otherwise arising out of or in connection with the performance of obligations under this Auction Code), even if that loss or damage was foreseeable by, or the actuality, inevitability or possibility of it was brought to the attention of NFPAS;
  - c) other than as provided for in Condition 12 of the Conditions of Sale, the revocation of any Renewables Obligation Certificate or REGOs.
  - d) For the avoidance of doubt, sub-Clauses (a) and (b) are severable.



- 10.2 Without limiting the generality of Clause 10.1 but subject to Clause 10.3 and 10.4, the aggregate liability of NFPAS, its officers, employees, agents and sub-contractors will not under any circumstances exceed £50,000 per calendar year, regardless of the cause or form of action.
- 10.3 Nothing in this Auction Code shall exclude or limit liability for death or personal injury resulting from negligence or fraudulent misrepresentation.
  - 10.4 Nothing in this Auction Code is intended to limit or exclude any liability on the part of NFPAS, its officers, employees, agents and sub-contractors where and to the extent that applicable law prohibits such exclusion or limitation.
  - 10.5 The Participant acknowledges that NFPAS holds the benefit of Clauses 10.1 to 10.4 inclusive on trust for the benefit of its officers, employees, agents and sub-contractors.

### 11 Intellectual Property

The Participant acknowledges that all copyright, trade marks, and other intellectual property rights in and relating to the Auction and the Auction Site are owned by NFPAS or its third party licensors. The Participant agrees not to use any of such intellectual property rights nor any data or information generated or derived from the Auction Site, except to the extent necessary to participate in the Auction in the manner anticipated in this Auction Code.

# 12 Confidentiality

- 12.1 Subject to the exceptions provided in Clause 12.2 below, NFPAS and the Participant shall not, at any time, whether before or after the expiration or termination of the Auction Period, without the prior written consent of the other, divulge or suffer or permit its officers, employees, agents or contractors to divulge to any person (other than to any of its or their respective officers or employees who require the same to enable them properly to carry out their duties) any of the contents of this Auction Code and any commercially confidential information which may come to a party's knowledge through the Auction Site or in the course of the Auction process or otherwise concerning the operations, contracts, commercial or financial arrangements or affairs of other party.
- 12.2 The restrictions imposed by Clause 12.1 shall not apply to the disclosure of any information:
- (a) which now or hereafter comes into the public domain otherwise than as a result of a breach of an undertaking of confidentiality or which is obtainable with no more than reasonable diligence from sources other than NFPAS or the Principal;
- (b) which is required by law to be disclosed to any person who is authorised by law to receive the same (including any disclosure required for the purposes of the RO Order, the ROS Order the RO(NI) Order); and/or the Electricity Regulations 2003, Electricity Regulations (Northern Ireland) 2003
- (c) which is required to be disclosed by the regulation of any recognised exchange upon which the share capital of the party making the disclosure is or is proposed to be from time to time listed or dealt in;

- (d) to a court, arbitrator or administrative tribunal in the course of proceedings before it which the disclosing party is a party;
- (e) in accordance with the provisions of the RO Order, the ROS Order, the RO(NI) Order or pursuant any licence granted under Section 6 of the Electricity Act 1989 or Article 10 of the Electricity (Northern Ireland) Order 1992 and/or the Electricity Regulations 2003, Electricity Regulations (Northern Ireland) 2003 of the Successful Bidder concerned;
- (f) to any consultants, banks or advisers to the disclosing party;
- (g) by any party to any instrument, agency of government or the European Community having jurisdiction in respect of inter-state commerce, competition or energy;
- (h) to the Authority, or to the Scottish Ministers, the Secretary of State or to the Department of Enterprise, Trade and Investment ("DETI") and their respective agents and successors to enable the Authority, DETI, the Scottish Ministers or the Secretary of State to monitor developments concerning the generation of electricity from non-fossil fuel sources; or
- (i) by NFPAS to its sub-contractors to the extent required to enable such sub-contractor to carry out NFPAS' obligations under the e-ROC and e-REGO Auction Code or e-ROC and e-REGO Conditions of Sale provided that such sub-contractors shall be made aware by NFPAS of its obligations thereunder and shall be required by NFPAS to observe the same restrictions on the use of the confidential information as are contained in this Clause 12.
  - 12.3 Before any party discloses any information in any of the circumstances described in Clause (f) (other than to legal advisers), it shall notify the other party of its intention to make such disclosure and procure the execution and delivery to that party of an undertaking executed by the person to whom the disclosure is proposed to be made being in the same terms mutatis mutandis as the undertakings contained in this Clause 12, but excluding Clause (f).

## 13 Amendments/Modifications

- 13.1 NFPAS reserves the right, at its discretion, to make additions, substitutions and modifications to any part of the Auction or the Auction Site.
- 13.2 This Auction Code may be amended by NFPAS at any time by posting details of the amendments at the Auction Site, and NFPAS shall use reasonable endeavours within one Banking Day to send an e-mail notification that it has done so to every Participant who has submitted the Registration Form for participating in the Auction to NFPAS in accordance with Clause 1. Unless otherwise stated, all amended terms shall automatically be effective 14 days after they are initially posted at the Auction Site, and the terms of this Auction Code may not otherwise be amended except in writing signed by the Participant and NFPAS.

## 14 Notices

14.1 All notices given or documents submitted to either party under or in connection with this Auction Code (save for the electronic submission of bids on the Auction Site and all notices specifically stated to be sent by e-mail) (collectively "Notices") must be left at or sent by prepaid first class post to the address or sent by fax to the fax number (marked for the attention of the person so specified) if to NFPAS, as specified below and if to the Participant, as specified in the Registration Form.

In the event that any provision of this Auction Code is found to be invalid by any court having competent jurisdiction, the invalidity of such provision will not affect the validity of the remaining provisions of this Auction Code which will remain in full force and effect.

### 15.3Entire Agreement

This Auction Code read together with the Registration Form and the e-ROC and e-REGO Conditions of Sale is the entire agreement between the Participant and NFPAS with respect to the Auction and the use of the Auction Site.

#### 15.4Non-waiver

Failure by either party to exercise any right or remedy under this Auction Code does not constitute a waiver of that right or remedy. The failure of NFPAS to act with respect to a breach by the Participant does not waive its right to act with respect to subsequent or similar breaches.

#### 15.5Tax

NFPAS accepts no responsibility for taxes on the Auction or the bids submitted at the Auction Site.
